- Candidates having **Special B.Ed.** are not eligible for the post of PGT/TGT.
- Knowledge of computer applications is desirable for all the posts.
- Proficiency of teaching in Hindi and English media for all the teaching posts is compulsory.
- No TA/DA will be paid to appear for interview or for joining if appointed on contractual basis.
- Eligible candidates may walk in for Interview with originals Certificates and one set of photo copies.
- Mere attending interview does not confer right of claim / right of employment/ appointment / place in panel. A candidate will be placed in Panel if the performance is up to the mark. (Scores 50% & above in interview or minimum cut off as decided by the interview committee). No separate weightage / marks for higher qualifications / experience will be given. Everything will be evaluated as a whole in interview.
- A contractual teacher if appointed, should immediately join. No extension / long leave /absenteeism will be allowed.
- Teachers engaged on contractual basis, would have no claim or right for appointment on regular basis nor will they be a part of the cadre of teachers of KVS.
- The employee, if appointed on contractual basis, will cease to be the employee and the contract stands automatically terminated on the joining of regular incumbent / till the end of the session/ need basis in case of instructors or coaches, whichever is earlier.
- Coaches / Instructors services are on need basis, hence as per the need they will be appointed and not for entire session.
- Salary will be paid as per the KVS rules and regulations.
- Staff appointed on contractual basis will not be entitled for pay during Vacation/Autumn Break /Winter Break.
- Teacher will not be entitled for pay, if remains absent on working day. In case of absence form duty, payment will be calculated on pro rata basis.
- Working hours shall be same as regular teacher.
- Contractual teacher, if appointed shall maintain absolute integrity towards his/her profession and justify his/her services. The students must be benefited with class room transaction / any allied academic activity. He /She should take utmost care of students under his/her care, as the safety and security of the students is paramount. He /She should not resort to corporal punishment. He /She should maintain himself / herself in such a way as the society expects from a teacher. They should follow the Code of Conduct for Teachers (KVS Education Code). Private tuitions will not be allowed.
- No other service benefits, like EL/ TA & DA/LTC/Medical etc., will be extended to contractual staff, if appointed. Tendency of frequent absenteeism or long leave will be viewed seriously.
- · Canvassing in any form leads to the disqualification of candidature.
- Interviews are conducted for preparing the panel of contractual staff and to appoint on purely contractual basis & need basis.
- Candidates are advised to check the eligibility criteria, before applying / attending interview. If a candidate does not possess the requisite qualification, she/he will not be interviewed. Even if

interviewed, found ineligible at later stage, will not be placed in Panel / appointed. Due to furnishing wrong information and appointed and found later, services will be terminated and appropriate action will be initiated against such candidates.

- Services of contractual teacher will be evaluated on a regular basis and services will be terminated if the performance is not up to the desired mark. He/ She should perform all the assignments / tasks allotted by Principal /HM / senior teacher/ Incharges of Committees, from time to time. Based on exigency / need of the services of the teacher, lower classes / higher classes may be assigned.
- Interviews are conducted for preparing the panel of contractual staff and to appoint on purely contractual basis & need basis.
- The employee, if appointed on contractual basis, will cease to be the employee and the contract stands automatically terminated on the joining of regular incumbent / till the end of the session/ need basis in case of instructors or coaches, whichever is earlier.

- A contractual teacher, if appointed, and later wants to discontinue for any reason, at least one month notice must be given for allowing the management to make further alternative arrangements.
- Before end of the contract, or before quitting with one month notice the contractual teacher must produce no dues certificate, failing which the salary due will be withheld.
- Contractual teacher, if appointed shall maintain absolute integrity towards his/ her profession and justify his/her services. The students must be benefited with class room transaction / any allied academic activity. He /She should take utmost care of students under his/her care, as the safety and security of the students is paramount. He /She should not resort to corporal punishment. He /She should maintain himself / herself in such a way as the society expects from a teacher.
- · Private tuitions will not be allowed.
- He/ She should perform all the assignments / tasks allotted by Principal /HM / senior teacher/ Incharges of Committees, from time to time. Based on exigency / need of the services of the teacher, lower classes / higher classes may be assigned.
- In case of vacancy the panel will be operated. If a candidate refuses / does not join in , he / she will not be considered further. Hence, it is made abundantly clear that no individual choice will be entertained.
- · Candidates are advised to check the eligibility criteria, before applying / attending interview. If a

candidate does not possess the requisite qualification, she/he will not be interviewed. Even if interviewed, found ineligible at later stage, will not be placed in Panel / appointed.
